Ref: Multiple underage drinking arrests (Update)

On June 7, 2009 at approximately 12:40 AM Officers responded to the area of 9 P Street for a reported large loud group. Upon arrival Officers found several people under the age of 21 that had been drinking alcoholic beverages.

One subject was injured reportedly attempting to escape the residence by jumping from a second story balcony. ***That person was transported to the Exeter Hospital and eventually transferred to the Beth Israel Deaconess Hospital in Boston. He was later discharged from that facility.***

In all, 32 persons were taken into custody and transported to the Hampton Police Department where they were charged with Unlawful Possession and Intoxication.
